NOMINATION INFORMATION FOR EXCHANGE COORDINATOR

The Exchange/Erasmus Coordinator will be asked to nominate their selected students using the online nomination form. The form is provided in Trinity's Fact Sheet for partner institutions. We must receive nominations by **30 March 2025** for first semester and full year exchange students. For students coming for the second semester only, the deadline to nominate is **30 October 2025**.

Nomination does not equate to an application and your student must follow the instructions to apply (see below) with a deadline of 15 April.

EXCHANGE STUDENT APPLICATION INFORMATION

Students on the European Erasmus+ programme will be contacted directly by the Erasmus Office (erasmus.incoming@tcd.ie) with Trinity's Erasmus application form.

Application Deadline for admission in Autumn term (called Michaelmas term): **15 April 2025** (also applies to full year academic exchanges)

Application deadline for admission in Spring term (called Hilary term): 15 October 2025

ENGLISH LANGUAGE REQUIREMENT

English is the language of teaching at Trinity College Dublin. If English is not your first language, you will be asked for proof of English language proficiency.

For students coming through European Erasmus+ agreements, they are expected to have B2 English level according to the Common European Framework of References for Languages (CEFR). For more details on CEFR, please refer to the Council of Europe's website:

Students need to provide a letter written by a qualified member of staff (Erasmus Coordinator, lecturer or tutor), confirming that the nominated student has acquired a B2 level in the English language. Erasmus students can also provide official certificates, such as TOEFL, IELTS etc. The results required can be found here: English language proficiency entry requirements.

For non-EU students coming through non-EU student exchange agreements, you must meet the following English language requirements here: <u>English language proficiency entry requirements</u>.

Trinity requires a high standard of proficiency for all of its students. The School of Linguistic, Speech and Communications Sciences runs a programme called <u>English for Academic Purposes</u> for students who wish to increase their proficiency of academic English. Modules on offer to exchange students are from the four years of the LL.B. programme, from 'Freshman' years (1st and 2nd Year) and 'Sophister' years (3rd and 4th year).

If certain modules are required by the home university, it is advisable that exchange students inform the School of Law in their application form, and email law.exchange@tcd.ie, so that these requirements can be accommodated—however it is not guaranteed.

Please note that some law modules are **not** available to exchange students:

- Foundations of Law I and II
- Clinical Legal Education
- Critical Perspectives on Law
- Current Issues in Constitutional Law
- Dissertation
- Mooting
- Responsible Business, EGS and Ethics
- Capstone Research Project

Exchange/Erasmus students cannot take modules on the LL.M. programme, even if they are Masters students in their home university.

The School of Law uses the ECTS and modules are worth either 5 or 10 ECTS. It is standard that students complete 30 ECTS for one semester and 60 ECTS for the full academic year.

Exchange students are expected to complete the standard form of assessment in their modules. Trinity Law School cannot accommodate special assessment requests that go beyond the academic curriculum in the Law School.

You will be asked to fill an online module enrolment form prior to arrival. While the Law School will try to accommodate your first preference of modules, some modules may be full or there can be time-table clashes,

so students need to have back-up modules. Students will finalise their module choices in the first weeks of term.

Students should note that in the event of there being a timetable clash with two modules, students will not be permitted to register for both modules.
